1- General Conditions:

- 1.1 The Ministry of Information (MOI) invites ONLY the specialized bidders to quote for the Supply, Commission, Test and Guarantee of spare parts to be used for satellite applications in DSNG47 vehicle.
- 1.2 All offered spare parts and required works shall be compatible with the current antenna control system that is stated in this document .
- 1.3 Supply, Commission, Test and Guarantee of **spare parts** to be used for MOI's DSNG 47 satellite uplink application as mentioned in part 3 Bill Of Quantities (B.O.Q) of this tender document.
- 1.4 The **spare parts** shall be commissioned within **2 months** from the date of signing the contract.
- 1.5 Following the successful commissioning to MOI and testing the Final Handing over Certificate (FHOC) is issued.
- 1.6 The warranty period, **twelve (12)** months, shall start from the date of issuing the FHOC, as detailed later in this T.D.
- 1.7 The bidder shall provide his support on all calibration and installation of the required parts under the assigned engineering team supervision.
- 1.8 The project must be executed and handed over to MOI under the full responsibility of the Contractor.
- 1.9 Testing equipment is the responsibility of the contractor - for this purpose only (i.e., shall not be the property of MOI).
- 1.10 Under the supervision of MOI assigned engineering team, the contractor shall inspect and test the required parts specified in this tender in the MOI premises.
- 1.11 The bidder must provide complete detailed data sheets , installation and calibration instructions sheets for all required parts proposed which must include all relevant technical information.
- 1.12 This FHOC shall be issued by the Ministry Of Information. FHOC issuance might be delayed for the period in which system failures occurred until the restoration of acceptable performance of the system to the normal acceptable state.

2- Warranty:

The contractor shall guarantee all spare parts of the project for a period of **twelve 12 months** after the date of the Final Handing Over Certificate (FHOC). All defective units, devices or components during this period shall be replaced by the contractor, at no extra cost or time added to the contract value and duration. During the warranty period if any repetitive catastrophic failure takes place in such a way that affects the performance, reliability, or availability of any of the project sub-systems, the contractor must bear full responsibility to correct and amend these problems in a good engineering practice at no extra cost to MOI.

The contractor's Warranty commitment should include the following services: The warranty shall include the free replacement and/or repair of the defective component parts of the system that have demonstrated defects in materials and/or manufacturing and/or design, including the dispatch of a local technician within forty eight (48) hours of notification of failure.

2.1 Transport costs relating to the shipment of any repair parts shall be included in the warranty.

2.2 During warranty, the Contractor must provide all the necessary updates free of charge to ensure the proper functioning and operation of parts placed in service.
