Project Objective:

The Ministry of information is looking to obtain several environment and network management and monitoring applications. And renew existing licenses.

General Requirements & Instructions to the Bidder:

The bidding company should meet the following requirements and qualifications. Failure to do so will disqualify the bidder and its bid will be rejected.

- The bidder should be known in Kuwait as a computer information technology provider for at least 5 years and must be registered at the Central Agency of Information Technology for the current year.
- A statement mandating that bidder must use Kuwait based technical resources, to assure continued support.
- It is a primary prerequisite that the selected bidder has extensive, successful experience in designing and implementing similar projects in Kuwait.
- Bidder should have a minimum of five (5) years of experience in the same field of this RFP requirement.
- Bidder should have successfully implemented similar solutions and provided support for solutions in public or private establishments of the same or similar size as the Ministry of Information in Kuwait.
- Bidder should have certified and trained engineers within the organization that have thorough knowledge of providing maintenance and support services for the solution offered.
- All information provided by the Ministry of Information related to this project is strictly confidential.
- Supply, installation and testing of the system should not exceed 30 days.
- The installation and implementation of the solution proposed should be done by the bidder.

Responsibility of selected bidder:

- Gather and document the solution detailed requirements.
- Register the required licenses and software under a ministry's dedicated account with the vendors.
- Planning of the Solution Design, Development and implementation.
- Configuring the system and hardware sizing.
- Adhere to the suggested production architecture.
- Local support for the duration of the contract.
- All License's expiry date must be unified and should be 6 months from date of activation.
